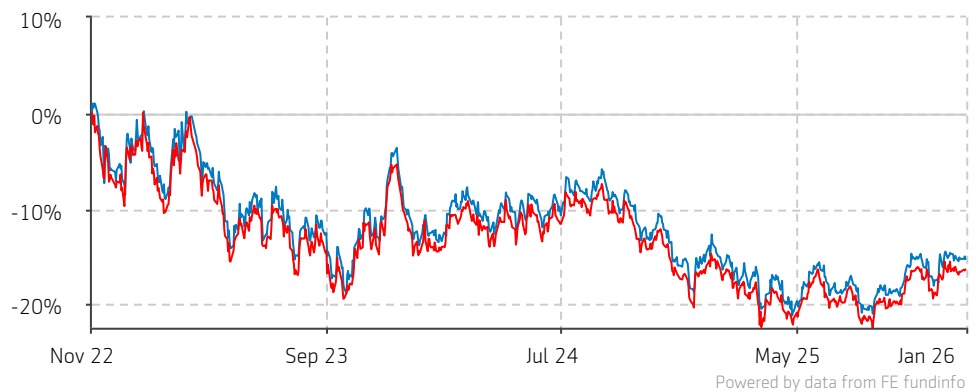
### Fund objective

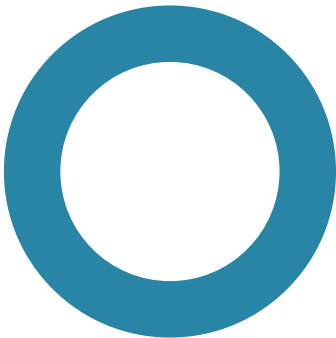
